Chapter 1 - Organisational Setup & Administration

1.1. The Commission

In exercise of the powers conferred under schedule XII (c) (3) of AP Reorganization Act, 2014, and in pursuance of Section 92 of A.P. Reorganisation Act, 2014, read with section 82 of the Electricity Act, Government of Telangana has constituted Telangana State Electricity Regulatory Commission, which came into existence on 03.11.2014. Further, Government of Telangana vide G.O. Ms. No. 13 Dated 22.10.2014 have appointed

- Sri. Ismail Ali Khan as Chairman,
- Sri. H. Srinivasulu, as Member (Finance) and
- Sri. L. Manohar Reddy as Member (Technical) – Retired in August 2016

1.2. Functions of the Commission:

- The State Commission shall discharge the following functions under Section 86(1) of the Act, namely: -
 - (a) determine the tariff for generation, supply, transmission and wheeling of electricity, wholesale, bulk or retail, as the case may be, within the State:

Providing that where open access has been permitted to a category of consumers under section 42, the State Commission shall determine only the wheeling charges and surcharge thereon, if any, for the said category of consumers;
 - (b) regulate electricity purchase and procurement process of distribution licensees including the price at which electricity shall be procured from the generating companies or licensees or from other sources through agreements for purchase of power for distribution and supply within the State;
 - (c) facilitate intra-state transmission and wheeling of electricity;
 - (d) issue licences to persons seeking to act as transmission licensees, distribution licensees and electricity traders with respect to their operations within the State;

- (e) promote co-generation and generation of electricity from renewable sources of energy by providing suitable measures for connectivity with the grid and sale of electricity to any person, and also specify, for purchase of electricity from such sources, a percentage of the total consumption of electricity in the area of a distribution licence;
 - (f) adjudicate upon the disputes between the licensees, and generating companies and to refer any dispute for arbitration;
 - (g) levy fee for the purposes of this Act;
 - (h) specify State Grid Code consistent with the Grid Code specified under clause(h) of sub-section (1) of section 79;
 - (i) specify or enforce standards with respect to quality, continuity and reliability of service by licensees;
 - (j) fix the trading margin in the intra-State trading of electricity, if considered, necessary; and
 - (k) discharge such other functions as may be assigned to it under this Act.
- The State Commission shall advise the State Government on all or any of the following matters under section 86(2) of the Act, namely : -
 - (a) promotion of competition, efficiency and economy in activities of the electricity industry;
 - (b) promotion of investment in electricity industry;
 - (c) reorganization and restructuring of electricity industry in the State;
 - (d) matters concerning generation, transmission, distribution and trading of electricity or any other matter referred to the State Commission by that Government.
 - As per section 86 (3) of the Act, the State Commission shall ensure transparency while exercising its powers and discharging its functions.

- As per section 86 (4) of the Act, in discharge of its functions the State Commission shall be guided by the National Electricity Policy, National Electricity Plan and tariff policy published under subsection (2) of section 3.

1.3. Powers of the Commission:

- The State Commission shall, for the purposes of any inquiry or proceedings under Electricity Act, have the same powers as are vested in a civil court under the Code of Civil Procedure, 1908 (5 of 1908) in respect of the following matters, namely: -
 - i. summoning and enforcing the attendance of any person and examining him on oath;
 - ii. discovery and production of any document or other material object producible as evidence;
 - iii. receiving evidence on affidavits;
 - iv. requisitioning of any public record;
 - v. issuing commission for the examination of witnesses;
 - vi. reviewing its decisions, directions and orders;
 - vii. any other matter which may be prescribed.
- The State Commission shall have the powers to pass such interim order in any proceeding, hearing or matter before the State Commission, as that Commission may consider appropriate.
- The State Commission may authorise any person, as it deems fit, to represent the interest of the consumers in the proceedings before it.

1.4. Infrastructure of the Commission

- **Office premises:** The Commission operates from its leased premises of 10,000 square feet at 5th Floor, Singareni Bhavan, Red Hills, Hyderabad.
- **Website:** The Commission's website is (www.tserc.gov.in) which is regularly maintained and updated. The Commission's orders, public announcements, press releases, reports, RTI, clarifications, objections received and Regulations notified by the Commission are updated on the website on a regular basis. The Commission has also designed and developed a website for the Vidyut Ombudsman, Telangana

(<http://vidyutombudsman-tserc.gov.in/>) wherein the orders, hearing schedules, the relevant Acts & Regulations, consumer grievances and details of the Consumer Grievance Redressal Forum are placed.

1.5. Staff of the Commission:

- The Commission to efficiently discharge its functions under the mandate of the Electricity Act 2003 comprises of staff with expertise and experience in engineering, economics, financial management, accounting, law, human resources, management information system and related skills.
- For functional convenience, the office of the Commission is organized into various departments such as Tariff, Law, Engineering, Human Resources and Accounts. Each department is headed by its functional expert, who renders his/her services to the Commission.
- The Commission, soon after its formation, has adopted all the regulations of erstwhile APERC vide regulation No. 1 of 2014. Accordingly, Regulation No 3 of 1999 and Regulation no 5 of 2013 of erstwhile APERC are applicable to the Officers and staff of the Commission. The Commission has forwarded a service regulation for Officers and Staff of the Commission to the Government of Telangana for its approval under section 91 (2) of Electricity Act, 2003. The Commission is yet to receive approval for the same. Pending receipt of the approval, the adopted regulations are in vogue.

1.3. Major Decisions in 2015-16

- Constituted State Advisory Committee with members from State Govt, NGOs, Academics, Industry, Farmers etc.
- Appointed consumer members for the CGRFs.
- Commission issued proceedings in the matter of safety measures enhancing the ex-gratia sum payable in a fatal accident resulting in death of a non-departmental person(s) and / or to an animal owing to electrocution.

Chapter 3 – Tariff Orders

3.1. Tariff filings

- 3.1.1. As per provisions of Section 64 of the Act, it is incumbent upon the Licensee to make an application to the Commission for determination of tariff in such manner and upon such terms as may be specified by the Regulations framed by the Commission.
- 3.1.2. The Licensees have sought permission from the Commission to file ARR for Retail Supply Business for FY 2015-16 on annual basis in view of the projection of energy availability, estimation of power purchase cost for the entire control period and Tariff uncertainty and the Commission, had granted permission to the Licensees for filing of ARR for Retail Supply Business only for FY 2016-17.
- 3.1.3. According to the Regulation No.4 of 2005, the Licensees were expected to file the necessary petitions for the approval of ARR and tariff for FY 2016-17 by 30th November 2016. However, the licensees have not filed the petitions by 30th November.
- 3.1.4. The Licensees have requested the Commission for extension of time for filing of ARR and Tariff proposal petitions from time to time. The main reasons stated by the licensees for seeking such extensions were the analysis of upcoming lift irrigation schemes to be energized in the ensuing year and the pending policy decisions of the State Government on
- supply of 9 hours power to agricultural consumers in the day time,
 - takeover of loans under the Ujwal Discom Assurance Yojana (UDAY) scheme by the Government of Telangana. According to the licensees these decisions were to have a significant impact on the financials and revenue requirement of the Licensees.
- 3.1.5. The extensions of time for filing of ARRs were filed jointly by the licensee in S. R. Nos. 60, and 61 of 2015 and S. R. Nos. 4, 7, 9, 10 and 12 of 2016 from time to time. The Commission has granted extension of time up to 05th February, 2016. The Licensees have filed the petition for ARR retail supply tariff approval on 08th March, 2016. After careful consideration of the reasons given by the Licensees, the Commission is of the view that the delay is neither willful nor wanton, therefore, the delay in filing is condoned by the Commission.

Chapter 5 – Consumer advocacy

5.1. Standards of Performance (SoP) of DISCOMS

5.1.1. TSERC (Licensees' Standards of Performance) Regulation, 2016 as amended from time to time contains provisions relating to (a) guaranteed SoP, being the minimum standards of service that a distribution licensee shall achieve to individual consumers; (b) overall service Standards which the licensee shall seek to achieve in the discharge of obligation as a Licensee; and (c) compensation payable and manner of payment of compensation to consumers for non-compliance of the Standards in terms of provisions of Section 57 of the Act, 2003

5.1.2. Consumer participation in Electricity Regulatory process is necessary and important to ensure transparency and accountability of the process. The Act 2003 requires the Commission to consult consumers on important policy and regulatory matters before arriving at any decision.

5.1.3. Regulatory matters were brought in the public domain through publication of Public Notice in daily newspapers, issuing Press Releases and also by placing the matter on the website of the Commission seeking suggestions/comments from the interested persons and stakeholders.

5.2. Consumer Grievance Redressal Forum

5.2.1. Each Forum shall consist of four Members, including Chairperson of the Forum. The DISCOM concerned appoints the Chairperson and two Members of its Forum on full time basis and the Commission nominates one independent Member who is familiar with consumer affairs

5.3. Vidyut Ombudsman

5.3.1. The Telangana State Electricity Regulatory Commission (TSERC) was constituted on 3rd November, 2014 after formation of the State of Telangana. By Regulation No. 1 of 2014 the previously subsisting Regulations, decisions, directions etc. were adapted.

5.3.2.A separate institution of Vidyut Ombudsman for the state of Telangana has been established under Sub Section (6) of Section 42 of the Electricity Act, 2003 on 11.02.2015. Sri R. Damodar, (Retd.) Secretary Law (Legal Affairs) was appointed

to discharge the functions of Vidyut Ombudsman for the state of Telangana and assumed charge on 11.02.2015.

5.3.3. The institution of Vidyut Ombudsman is an authority providing an effective, alternative, time-bound and cost-less route for resolving the problems of the Electricity Consumers. Any person affected by any deficiency in electricity related service can approach the Vidyut Ombudsman for redressal of grievances only by way of an appeal. Keeping in view the goal of speedy redressal of Appeals arising out of decisions of the Consumer Grievances Redressal Forums, the appeals are being disposed of with no expenses to the aggrieved parties, with the cost being borne by the Power Distribution Companies.

5.3.4. Any Complainant, if aggrieved by the non-redressal of the grievance by the Forum, may make a representation to the Vidyut Ombudsman within thirty (30) days from the date of the receipt of the decision of the Forum or from the date of the expiry of the period within which the Forum was required to take decision and communicate the same to the Complainant. However, the Vidyut Ombudsman may entertain an appeal after the expiry of the thirty (30) days period, if satisfied that there is sufficient cause for not filing it within that period.

5.3.5. The Vidyut Ombudsman shall decide the representation finally within three (3) months from the date of the receipt of the representation of the Complainant and in the event the representation is not decided within three months, the Vidyut Ombudsman shall record the reasons thereof, including the cost to be paid by the licensee in case the reasons for the delay is attributable to the licensee. In case the delay is for reasons attributable to the Complainant, the Vidyut Ombudsman may reject the representation. Further, the Vidyut Ombudsman may pass such interim orders as the Vidyut Ombudsman may consider appropriate pending the final decision on the representation.

Chapter 6 – Accounts and Audit

The TSERC was constituted vide G.O.Ms. No. 3, Dated: 26-07-2014 under Section 92 of the A.P. Reorganisation Act, 2014, read with section 82 of the Electricity Act, 2003 and came into existence on 03.11.2014. As per the G.O. Ms. No.14, dated: 01.11.2014, the assets and liabilities of the erstwhile APERC were provisionally allocated between the TSERC and the APERC. From 03.11.2014 separate accounts have been maintained for the TSERC.

Grants received from Govt. of Telangana State:

The expenditure towards salaries and other office expenditure of TSERC is partly met from the Grants-in-Aid from the Govt. of Telangana and the followings grants were released during the year 2015-16.

Other income received:

TSERC has received interest income credited by the bank for Rs.39,65,317/- and interest accrued but not credited for 2015-16 is Rs.57,66,36/-. Miscellaneous income is received for a sum of Rs.1,08,15,627/-, comprising of a sum of Rs.1,06,09,500/- towards petition filing fee and a sum of Rs.99,200/- towards sale of tariff orders, Rs.1,04,680/- towards interest on officers and staff advances and Rs.2,247/- towards miscellaneous.

Receipts from APERC:

Towards the 50% share from the combined funds of erstwhile APERC which were held up, were released by the APERC for a sum of Rs.48,85,110/-.

Expenditure incurred towards salaries and Other benefits:

Expenditure incurred towards salaries, allowances and other benefits to the Commission, Officers and Staff and pensions and payment towards retirement benefit fund was a sum of Rs.625.63 lakhs.

Expenditure incurred towards Office expenses:

Expenses incurred towards office and other administrative expenses during the period were a sum of Rs.151.01 lakhs.

6.1. Audit Report

Audit of Accounts:

The Comptroller & Auditor General of India have audited the financial statements of the Commission in accordance with section 104(2) of the Electricity Act, 2003. The Separate Audit Report containing the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment received vide letter No. PAG(Audit)/ES(Power)/TSERC/AA-14-16/2017-18/07 Dated 04.09.2017 is furnished hereunder.

SEPARATE AUDIT REPORT OF THE COMPTROLLER & AUDITOR GENERAL OF INDIA ON THE ACCOUNTS OF TELANGANA STATE ELECTRICITY REGULATORY COMMISSION, HYDERABAD FOR THE YEAR ENDED 31ST MARCH, 2016

1. We have audited the attached Balance Sheet of **Telangana State Electricity Regulatory Commission (TSERC)** as on 31st March, 2016 and the Income and Expenditure Account/Receipts and Payments Account for the period from 01.04.2015 to 31.03.2016 under section 19(2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 104 (2) of the Electricity Act, 2003. These financial statements are the responsibility of the TSERC's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules and Regulations (Propriety and Regularity), efficiency-cum-performance aspects etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on the preliminary observations made by us, the accounts of the Commission have been revised. **Due to revision, the excess of Income over expenditure has been increased by Rs.14.03 lakh and total assets and liabilities of the balance sheet have also been increased by Rs.14.77 lakh.**

5. Based on our audit, we report that:
- i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purposes of our audit;
 - ii. The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by the Committee of Experts formed by Central Government subject to our comments.
 - iii. In our opinion, proper books of accounts and other relevant records have been maintained by the TSERC as required under section 104 (1) of the Electricity Act, 2003 in so far as it appears from our examination of such books.
 - iv. We further report that:

(A). Comments on Accounts:

Income and Expenditure:

Income – Fees (Schedule 7) : Rs.8.39 Crore

1. During the year 2015-16, TSERC had received Rs.53.76 lakh from the licensees towards Vidyut Ombudsman expenditure and this amount was treated as income under Schedule 7. Against this an amount of Rs.38.07 lakh was spent towards revenue expenditure during the year 2015-16. The inclusion of balance amount (Rs.53.76 lakh – Rs.38.07 lakh) had resulted in overstatement of income over expenditure for the year by Rs.15.69 lakh. Consequently the capital fund was overstated by Rs.15.69 lakh and current liability (others) was understood by Rs.15.69 lakh.

Expenditure: Pension & Retirement Benefits (Schedule 10)

Paid to TSERC Employee Pension Trust (item 3 b) : Rs.2.76 Crore

2. The above does not include an amount of Rs.3.88 Crore being the current year contribution towards superannuation liability funding to be payable to the LIC, for the year 2015-16. Due to above omission, 'Establishment Expenses (Schedule - 10)' as well as Current Liabilities (Schedule – 2) were understood by Rs.3.88 crore with consequential impact of overstatement of 'Excess of Income over Expenditure' by similar amount

Significant Accounting Policies (Schedule – 12)

3. Regarding Leave Encashment and Gratuity stated vide Accounting Policy No.9 of Schedule – 12 (Significant Accounting Policies) is not factually correct as it should make suitable provision for terminal benefits of gratuity and leave encashment in the financial statements.

Format of Accounts

4. The common format of accounts of autonomous organizations prescribed by the committee of experts would be applicable, in the interest of transparency and comparability, to all autonomous bodies governed by separate acts of Parliament and where CAG is the sole auditor. However, the format adopted by the TSERC did not reflect references to Notes to accounts and Significant Accounting Policies relating to Fixed Assets and Grants in the Balance Sheet (Schedule 24 as per prescribed format).

(B) Grants-in-Aid:

Out of the grants-in-aid of Rs.5.13 crore received during the said period, TSERC utilized the entire amount leaving Nil balance as unutilized grant as on 31.03.2016.

- i. Subject to our observations in the preceding paragraph, we report that the Balance Sheet and Income and Expenditure/Receipts and Payments Account dealt with by this report are in agreement with the books of accounts.
- ii. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Notes, and subject to the significant matters stated above and other matters mentioned in the Annexure to this Separate Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.
- a) In so far as it relates to the Balance Sheet of the state of affairs of the Telangana State Electricity Regulatory Commission as at 31 March, 2016; and
- b) In so far as it relates to the Income and Expenditure Account of the surplus for period from 01.04.2015 to 31.03.2016.

SCHEDULE-12
SIGNIFICANT ACCOUNTING POLICIES

1. As per the G.O. Ms. No.14, dtd: 01.11.2014, the assets and liabilities of the erstwhile APERC were provisionally allocated between the TSERC and the APERC. From 03.11.2014 separate accounts have been maintained for the TSERC.
2. The accounts are prepared on accrual system except for stationery and other petty expenses.
3. The accounts are prepared based on the report of the expert committee on common format of Accounts for autonomous bodies.
4. The APERC Funds Rules, 2014 were issued in terms of section 103 of the Electricity Act, 2003 Vide the G.O.Ms.No.19, Energy (Power-III) Dept., Dt: 08.05.2014 and TSERC has adopted all the Regulations/ Orders of the erstwhile APERC. Subsequently, separate TSERC Fund Rules, 2015 have been issued vide G.O.Ms.No.15, Energy (Budget) Dept. Dt:04.05.2015.
5. All revenues of the Commission including the grants and loans by the Government, the fees and other sums received by the Commission were remitted to the Fund. All the expenditure of the Commission was met from the Fund.
6. The petition fee is recognized as revenue as and when the petitions received and accepted. License fee revenue is based on the energy handled by the distribution licensees and allocated capacity of the Transmission licensee during the year.
7. Depreciation on the assets of the Commission (excluding the furnishing articles provided at the residences of the Chairman and the Members of the Commission) is provided at the SLM rates specified in the Companies Act, 2013.
8. Depreciation on the Furnishing Articles supplied to the Chairman Members of the Commission is provided at 50 percent on SLM in respect of articles falling under Annexure I and 15 percent on WDV method in respect of articles specified in Annexure II in line with High Court Judges (Writing off, selling and utilization of Furnishing Articles) Rules, 1990.
9. Pension fund has been created to meet the future pension liability of employees of the TSERC excluding the leave encashment and gratuity duly constituting the TSERC Employees Pension Trust.
